Figure 1 Three dimensional policy space of the cube




Figure 2 A view from the top of the cube: Economics & Migration




Figure 3 A view from the side of the cube: EU integration & Immigration




Figure 4 A view from the front of the cube: Economics & EU integration




Figure 5 A cube with a pyramid shaped polyhedron




Figure 6 Coalition VVD-CDA-D66-GL




Figure 7 Coalition VVD-CDA-D66-CU




Figure 8 Coalition VVD-CDA-D66-PvdA




Figure 9 Coalition VVD-CDA-D66-PvdA-CU





Figure 10 The left-right dimension




